Bids will be received at the Office of the Township Clerk, Joliet Township Government Office, 175 W. Jefferson Street, Joliet, IL 60432, before 1:30 p.m. on Friday, September 20, 2019. Thereafter all proposals received will be publicly opened at the Town Hall meeting room, 175 W. Jefferson Street, Joliet, IL 60432, at the north end of the Township Building and the bid price read aloud.

All proposals must be accompanied by a bid bond, bank cashier's check, bank draft, or certified check for not less than five (5) percent of the amount of the bid.

In addition, all bidders must comply with the Responsible Bidders Act of the State of Illinois. The successful bidder will be required to post performance security and to provide a Certificate of Insurance as set forth in the Invitation to Bid and the general terms and conditions. Bidders are required to be pre-qualified through the Illinois Department of Transportation. The awarded contractor will be required to participate in a preconstruction meeting. The Joliet Township Road District reserves the right to reject any and all bids, part of any and all bids, or to waive technical errors or omissions in bids.

Contractors must comply with applicable prevailing wage laws of the State of Illinois.

No bidder may withdraw their bid within 30 days after the actual date of the opening thereof.
