

April 27, 2021 Public Hearing Minutes
General Town Budget Ordinance No. 370-2021

State of Illinois,
County of Will,
Town of Joliet,

The public hearing scheduled to be held in said Town and County in the State of Illinois at 175 West Jefferson Street, Town Hall meeting room, Joliet Township Office Building, April 27, 2021 was opened by the Town Clerk Julie Kinsella at 5:05 p.m.

The public hearing is for the final presentation of the 2022 General Town Budget Ordinance No. 370-2021. The following official business was transacted:

The Town Clerk accepted the previous roll as called at the Regular Town Board meeting which was recessed for this hearing.¹

Clerk Kinsella verified that in accordance with the legal notice published in the Joliet Herald News on March 24, 2021 the Public Hearing on Ordinance No. 370-2021 is now open. The Clerk read the Public Notice as published. Clerk then asked the Board to review Ordinance No. 370-2021 Budget & Appropriation- Joliet Township.

The Town Clerk stated that comments and/or discussion on Ordinance No. 370-2021 are now in order and any persons wishing to speak on it may do so now. The Town Board had previously received copies of the ordinance and have been given the Ordinance No 370-2021 Budget & Appropriation –Joliet Township with the updates as listed below to the board members.

Finance Director Witt noted that the following changes were made from the March 24, 2021 posted budget:

1. ALL funds beginning balances were changed from the estimated beginning balance to the actual beginning balance on 4/1/21 due to year end final figures now being available.
2. The Personal Property Replacement Tax revenue was changed in the GT and GA fund to reflect an increase in expected PPRT revenues.
3. The IMRF line item was decreased in the GT, Assessor, GA, and AC funds to reflect the decrease in the preliminary IMRF rate discussed at the last meeting.
4. The Social Security line item in the GA fund was increased from 6820 to 9820 due to original scrivener error.
5. The final total expenditures for the Budget & Appropriation Ordinance 370-2021 DECREASED from \$3,741,108.00 to \$3,737,038.00

No other public comment was given. Trustee Slattery made a motion to adopt Ordinance No. 370-2021 Budget & Appropriation-Joliet Township, seconded by Trustee Verdin. There were no questions asked about the motion. Roll call vote was taken.²
