Supervisor stated goal is to help agencies/organizations and help connect with others and relationships for betterment of community. Supervisor Contreras motioned to approve \$5,000 to Blue Print Agency. Trustee Ibarra motioned to approve \$5,000 grant to Blue Print Agency; Seconded by Trustee Slattery. #### **REPORTS:**

### Senior Liaison March Meetings, Jeff Wallace:

Senior Citizen associate 102 members were present. President Chuck Corso introduced new members and discussed about upcoming meeting for June-July. Senior service calendar and door prize were provided. Jeff spoke about upcoming veteran's luncheon. 50/50 raffle was held. Widow widowers 30 members were in attendance. Pam discussed voter participation and took questions as well as legal questions for seniors. Dr. Shelby discussed atrial fibrillation. Jeff brough senior calendars and senior prizes. St. Joes seniors- 60 members were present as well as Alicia and new interns. Rich introduced a new member. Jeff discussed upcoming luncheon for veterans. Suzanna then explained vaccination services and costs for animals in Township. Alicia spoke of township clerk duties and introduced new interns. Lunch was served and calendars were provided. and a 50/50 raffle was held. 428 Seniors 48 members were present. Do not meet in June-August. Box lunch was served, and Jeff provided senior service calendars and magazine novation provided entertainment. 50/50 Raffle was held. Latino social club with 7 members at Hartman center. Zumba was held. Mexican subs were served as well as Mexican bingo. Jeff stated he had a great time. St. Paul lights 54 members attended. Moose seniors thirty members were in attendance. Jeff stated seniors were at the casino. Members do not meet in July and will have a picnic August 9. # General Assistance Director, Patricia Venziano:

Joliet Township has been approved with an electronic ID number IRS approval and will be able a stainable site for next tax season. Soledad and Sue have been distributing flyers at local food pantries. Twenty people applied for assistance from LIHEAP program offered through Community Concerns and required another employee to help with applications. Community concerns will reach out to Township sometime in the summer and will be setting Township office as an outreach site once a month. Soledad, Sue, and Patricia attended bi-annual community partnership luncheon by Catholic charities. The department is coordinating with Ana on which events will be attending this summer.

## Animal Control Director, Whitney McGill:

Spring and summer volunteer orientation and welcomed thirteen volunteers for their program. Next orientation will be in the fall and date is yet to be determined. Animal control visited Lynne Thigpen elementary school with couple of dogs to give presentation to kids about animal control. Kids gave a warm welcome to animal control and their dogs and learned about animal safety. Animal control is getting ready for plaza on 66 pet rescue day event on June 18<sup>th</sup>. With weather permitting, animals will be taken for adoption if not, pamphlets will be provided for community outreach. Animal control will be sponsoring dog day at Duly at slammers field on August 16<sup>th</sup> at 6:30. Supervisor Contreras stated tickets may be available for purchase as soon as next week. Whitney attended a welfare conference in Bloomington and learned new impacts to animal welfare in Illinois as well as new ideas to benefit sheltered pets.

#### Financial Director Ivan Diaz

Financial Director- Ivan, Town Clerk- Alicia, and Supervisor Contreras attended an informational session American Rescue plan is federal dollars given to Will county's townships. Joliet Township received approximately \$600,000 and will be working on applying for the funds to meet the July 1 deadline and begin reimbursement process. Disbursements from Will County will begin on August 1st. Eligible period of expenses that could be reimbursed is from March 1,2021 through December 31,2024 if funding is available and it does not have to be spent from that period. Supervisor

Contreras stated that there are some expenditures Joliet Township has already incurred that could possibly be applied for reimbursement.

### Clerk Alicia Morales:

Working on day-to-day and including preparing the agenda. She is working with two interns. Interns introduced themselves. Clerk Morales states interns have been digitizing al documents in the building to keep records updated and organized, the interns have assisted Joliet Township Animal control working on different projects. They have been preparing an inventory tracking system of medical equipment for medical loaning closet. They have been assisting with the newsletter including layout and content for the newsletter and website. They have also been performing general research in clerk's office, creating various flyers for events including grass cutting due to increased calls in May. Clerk Alicia Morales also attended and introduced interns to senior groups that the Township supports. She has attended an informational meeting at the Will County Executive office with Supervisor Contreras and Financial director, Ivan regarding the reimbursement COVID funds

<u>Supervisor's Report: Angel Contreras</u> – Supervisor Contreras stated that Intern Darrick Mainor has been working on cemetery project and during annual Memorial Day event. Two daughters from the union were in attendance every year and were contacted after event to help preserve history, gather information for website and digitize. Supervisor Contreras also states, working with the museum and setting up a tour date to be open for the public. In addition to working with other agencies, Supervisor Contreras and Clerk, Alicia Morales met with the Will County Land Use Department to fill any gaps with grass maintenance of vacant properties. Supervisor has met with legal counsel to review options as to how the township including unincorporated Joliet continues to improve by working on agreements to be more responsive to residents. Supervisor also states, new website will be up in the next week. Derek is working on grant applications and digitizing forms for more efficient uploading.
