## Reports

# Highway Commissioner, Vince Alessio

Highway Commissioner Alessio stated road district is day to day for that last few months. Road district has completed drainage project that has been in the works since 2016. Additionally working on 2 bridge projects, bridge project plan is 60 percent completed which is sent to regulators and sent for environmental approvals. from is continuing with highway maintenance. Additionally, road district has met with engineering firm regarding residents' concern from August meeting. Vince is in contact with residents and stated Engineering firm will be on site when engineering firm has availability. Supervisor Contreras and Highway Commissioner held a private meeting with residents to find way to better serve them. Vince states water is flowing better once RD removed pipes that were placed about 27 years ago as well as cleaned the ditch.

## Township Assessor, Jim Brenczewski

Assessor's office has been busy with phone calls due to 30-day window for residents to file complaints. The window closed Monday. Now assessor's office must present with evidence to why it is right and board reviews and determines decision of assessments.

# General Assistance Director, Patricia Venziano

Sue and Alejandra have continued to represent Township at various outreach events. Alejandra has been creating a flyer for Suicide prevention in September. Township will be providing gun locks and Narcan for interested residents. Will county center for community concerns was at township for outreach event. Patricia will be working to have them once again for October in hopes of having regular outreach event at Township as it was a successful event. Supervisor Contreras and Patricia have decided to add temporary handicap placards as part of GA services for residents for 90 days with anticipation of launching service in October. Patricia states there is an influx of residents applying for assistance and keeping busy.

#### Finance Director, Ivan Diaz

The personal property replacement tax is also affecting the general town budget due to updates and due to certain percentage paid to Crest hill and Rockdale. Additionally, other changes in general town fund are an addition to capital fund transfer for extra funds being received. Also lower of expense items that is not needed such as legal fees, building approvements, raise in professional fees and updated in interest amounts of revenue, monthly subscriptions, and increase in general assistance due to equipment costs, and increase salaries for future employees for transportation program. Ivan and Supervisor Contreras have a meeting September 14<sup>th</sup> regarding ARPA application and updates. Additionally, audit is upcoming.

# Animal Control Director Whitney McGill

Recent adoption and outreach events were successful. Next adoption event will be in Abri Credit Union on September 24<sup>th</sup>. Animal control will be hosting their fall volunteer orientation on September 17<sup>th</sup>. Whitney states there has not been as many volunteers post covid. A couple of weekend employees have left due to college and has held interviews. Additionally, kennel order has arrived and is ready to be installed as well as updated dog room. Additionally, it is a very busy time at Animal control with filled occupancy. Therefore, adoption fees have been waived to make room and has been successful. Supervisor Contreras and Animal control director have

been discussing certain gaps to fill within Animal control such as in house veterinary. Additionally, Trustee Ferrell will assist in coordinating with animal control.

### Senior Liaison, Jeff Wallace

Jeff Wallace attends 7-9 senior group meetings each month. He meets with them, make sure they receive their funding, and to answer any questions about Joliet Township. Senior Liaison brought senior services calendars and a door prize to meetings. September 5th 47 Moose seniors were in attendance along with a successful picnic members brought a district pass and had fun. Senior Citizens Association 117 members were in attendance. Widow widower's member spoke of trips and speakers were in attendance, S.O.A.R. meeting had 75 members in attendance along with Clerk Alicia Morales and Supervisor Angel Contreras. Angel spoke of services Joliet Township offers. St. Paul's senior club had 60 to 70 members were present. All officers gave reports except treasurer. Additionally, members took vote to give \$2,000 to church for all their help. Jeff Wallace commentated a flag folding ceremony with the help of 2 veterans. Ana recorded the event. Retired Teachers Association met on June 22nd with 48 members present. Both met with DuPage township and met with supervisor to discuss best practices and implement Senior services into Joliet Township. Additionally, Township clerk discussed purpose of Latino Social Club and coaching for leadership. Latino Social Club attended a trip to The Shrine of our Lady of Guadalupe in Des Planes. The club is continuing to grow and are eager for upcoming meetings.

#### **Supervisor Angel Contreras**

Supervisor Angel Contreras began his report by stating Township is investing in durable equipment and is working with General assistance. Additionally, ARPA grants is almost completed. Will Grundy Medical there is another ARPA grant and is due this Friday. Once it is submitted it ill be sent to trustees. Pace transportation is a work in progress and working together with other agencies.
