#### Approval of the Minutes:

Regular Town Minutes: Trustee Ibarra moved to approve the minutes of the October 11, 2022, Regular Town Board Meeting, Seconded by Trustee Escutia. A roll call vote was taken.<sup>1</sup>

#### **New Business:**

Supervisor Contreras speaks about the Annual Grants given from the Senior Tax Levy. These are the recurring grants since last year. The only new one is the Club Social Latino, which has already been addressed. Supervisor Contreras askes the Trustees if they would like him to name each Senior Tax Levy Grant individually or can he just say what the amounts are and Trustee Ibarra comments that if there are no questions, then Supervisor Contreras can just say what the pricing is, Township Attorney Brian Wellner concurs. Supervisor Contreras acknowledges amount. Supervisor Contreras continues with the Approval of the 2022-2023 Organization from the Senior Tax Levy's beginning with the Catholic Charities Foster Grandparent Program; \$15,000.00 annually and it stays the same. The Senior Companion Program; \$11,000.00. Prairie State Legal

Services; \$21,000.00. Senior Services of Will County; \$30,000.00. Supervisor Contreras asks for a Motion to approve these Senior Tax Levy Grants from 2022-2023. Trustee Ibarra made the motion to approve. Trustee Escutia seconded. A roll call vote was taken.<sup>2</sup>

The next items are the Senior Clubs from the Senior Tax Levy Grants. The ones that submitted annually and everyone has received in the past and the amounts stayed the same. Club Social Latino from the Spanish Community Center; \$3,500.00. St. John's Baptist Parish; \$3,500.00. Joliet Area Retired Teachers Association; \$2,500.00. Joliet Moose Senior Club; \$3,500.00. National Hook-Up of Black Women; \$3,000.00. Senior Citizen Association; \$7,500.00. SOAR; \$3,500.00. St. Joseph Parish Seniors; \$3,500.00 and The Paulites; \$3,500.00. Trustee Ibarra made the motion to approve. Trustee Slattery seconded. A roll call vote was taken <sup>3</sup>. Supervisor Contreras comments that there are a few others that haven't yet applied but his office will reach out to them.

Items in the packets last time; Forrest Park Community Center requested \$20,000.00 for their Food Pantry and after speaking with them, Supervisor Contreras offered them \$7,500.00. Supervisor Contreras asks for a Motion to approve Forrest Park Community Center Food Pantry. Trustee Ibarra made the motion to approve. Trustee Escutia seconded. A roll call vote was taken. 4.

Golden Stars-Casa de la Cultura, presented last month and asked for \$20,000.00 and after speaking with them, Supervisor Contreras agreed to help them with \$5,000.00 and offered them to apply next year. Trustee Ibarra made the motion to approve. Trustee Slattery seconded. A roll call vote was taken. <sup>5</sup>.

## Senior Liaison, Jeff Wallace

Senior Liaison said that he will see them next Saturday, he is not sure if their paperwork got lost. Mr. Wallace attended the following: Senior Citizen's group on October 13<sup>th</sup> and one hundred-eighty (180) members were in attendance and the President spoke about the upcoming Christmas luncheon on December 8<sup>th</sup> and the association was taking dues for the upcoming year. He took Senior Service calendars and a door prize. He spoke about having another Veteran's Lunch.

Mr. Wallace attended the St. Joe's Seniors on October 19<sup>th</sup>. Fifty-seven (57) members were in attendance. President Rich Rich welcomed everyone and introduced some new members. Everyone gave there reports, except for the secretary Barb, she was in the hospital. A great lunch was provided. He took Senior Service calendars and a door prize and spoke about the Township.

St. Ray's Seniors Club was on October 13<sup>th</sup>. Thirty (30) members were in attendance. A box lunch was served. Their entertainment was Frank K. Duo. # Clerk Alicia Morales

Clerk Morales greeted everyone mentioned that has been day-to-day business as usual. The Clerks office did hire someone, Ms. Veronica Aguilera. She will be going on the approval for the next board meeting for the official Deputy Clerk. An extensive search was done on Indeed, we took in several resumes and held several interviews. She will be on the next agenda for Board approval.

Clerk Morales noted that she attended on the 4<sup>th</sup> Sunday the Senior Club Social Latino's meeting which was held at a new location at Mt. Carmel Hall on Collins St., which is normally held at the Hartman Center, but it wasn't available due to it being overbooked. They had the Lyon's Club come out and talk about their hearing aids, glasses and their history and all the wonderful work they do. Twenty-three (23) people were in attendance and none of them have ever heard about the Lyon's Club. They passed out applications so that everyone can apply for hearing aids or glasses.

# **Supervisor Angel Contreras**

Supervisor Contreras' report is that his office has been discussing the printed newsletter and they are reaching out to everyone to put it together and this will be a Winter/New Year Edition.

He also will contact the board individual before any approvals regarding the new potential facility. He also mentioned that next week, we have the budget meeting with Ivan and the approval of the amended budget.

Trustee, Suzanna Ibarra mentions that Joliet Township Government donated Bubble Wands for the Holsten Human Capital's Trunk or Treat and she thought that maybe the adults like them just as much as the kids because there was so many pictures with Adults posing with the Bubble Wands and although Joliet Township Government General Assistance Department couldn't be there to represent, they still donated things and she thanks on behalf of Holsten Human Capital. Trustee Ibarra also speaks about the LIHEAP event and how she mostly saw Spanish speaking people walk in through the doors and that Caseworker Alejandra was there and jumped right in and helped. She sees great improvements happening.

Trustee Slattery thanked whom ever worked on the Senior Tax Levy Applications, stating "they were great! We have never had them so thorough before with the breakdowns." Supervisor Contreras mentions that it was Ana Campa Castillo.
