We have formed a partnership with Forepaws, a pet food store in Minooka, that allows us to house adoptable cats in their free roaming cat socialization room. They can conduct adoptions for the cats at their facility 7 days a week and all we need to do is provide the healthy, fully vetted cats and their food! We are looking forward to this partnership as it allows us to adopt more cats due to our own facility having more room and also enabling adoptions during hours JTAC is closed. Officer Rivera has resigned from the animal control officer position and Assistant Director Becky and I are in the process of interviewing candidates to fill the vacancy.
