A RESOLUTION APPOINTING AN AUTHORIZED AGENT FOR JOLIET TOWNSHIP TO THE ILLINOIS MUNICIPAL RETIREMENT FUND

- WHEREAS, Joliet Township, County of Will, State of Illinois (the "Township") is a duly organized and existing township and a unit of a local government organized under the laws of the State of Illinois and is operating under the provisions of the Illinois Township, 60 ILCS 1/1-1, et seq., and all laws amendatory thereto; and
- WHEREAS, Joliet Township participates in the Illinois Municipal Retirement Fund ("IMRF") pursuant to the Illinois Pension Code, § 7-132 (40 ILCS 5/7-132); and
- WHEREAS, the Illinois Pension Code requires that each unit of local government participating in the IMRF appoint a qualified party as an Authorized Agent on behalf of the township; and
- WHEREAS, the Supervisor and the Board of Trustees (the "Board") wish to appoint Cesar Guerrero, as the Township's Authorized Agent to perform all of the duties set forth in the Illinois Pension Code, § 7-135 (40 ILCS 5/7-135).
- **NOW, THEREFORE, BE IT RESOLVED** by the Supervisor and the Board of Trustees of the Joliet Township, Will County, Illinois, as follows:
- <u>Section 1:</u> That all of the recitals contained in the preambles of this Resolution are true and correct and are hereby incorporated into this Resolution as if fully set forth herein.
- <u>Section 2:</u> That the Township Board hereby appoints Township Supervisor, Cesar Guerrero as the Township's Authorized Agent for the IMRF, as identified in **Exhibit A**, which is attached hereto and incorporated herein.
- Section 3: That the Township Supervisor or his designee is authorized to submit the Notice of Appointment of Authorized Agent, identified in Exhibit A, and any other required forms or documentation to the IMRF in order to effectuate the appointment.
- Section 4: If any section, paragraph, clause, or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.
- Section 5: All resolutions, motions, or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.
 - Section 6: This Resolution shall be in full force and effect upon its passage and approval.
