WHEREAS, Section 75-45 of the Township Code (60 ILCS 1/75-45) provides that the Township Clerk, when authorized by the township board, may appoint one deputy clerk; and

WHEREAS, the Joliet Township Clerk seeks to appoint a Deputy Clerk consistent with applicable law; and

WHEREAS, the Joliet Township Board finds it in the best interest of the Township to authorize and approve the appointment of a Deputy Clerk; and

WHEREAS, the Joliet Township Board finds it in the best interest of the Township to authorize and approve the appointment of Juan M. Guzman as Deputy Clerk.

NOW, THEREFORE, BE IT RESOLVED BY THE SUPERVISOR AND TOWNSHIP TRUSTEES OF JOLIET TOWNSHIP, WILL COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. RECITALS INCORPORATED

The recitals set forth hereinabove shall be and are hereby incorporated as findings of fact as if said recitals were fully set forth herein.

SECTION 2. DEPUTY CLERK APPOINTED

That the Joliet Township Clerk hereby appoints Juan M. Guzman to serve as the Deputy Clerk, and the Joliet Township Board hereby authorizes and approves such appointment.

SECTION 3. SEVERABILITY

If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4. REPEALER

Any policy, resolution, or ordinance that conflicts with the provisions of this ordinance shall be and is hereby repealed to the extent of such conflict.

SECTION 5. EFFECTIVE DATE

This Resolution shall be effective after its passage and approval as made and provided by law.
