ORDINANCE NO. 403-2024**

An ordinance levying taxes for all Town purposes for Joliet Township, Will County, Illinois for the tax year 2024, collectable in 2025.

Be It Ordained by the Board of Trustees of Joliet Township, Will County, Illinois, as follows:

SECTION 1: That the sum of Two Million, Nine Hundred Thousand (\$2,900,000) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund, General Assistance Fund, Senior Citizens Fund,  
for the year 2025.




