## ORDINANCE NUMBER 408-2025 AN ORDINANCE ESTABLISHING OPEN MEETINGS ACT REMOTE ATTENDANCE POLICY FOR JOLIET TOWNSHIP, WILL COUNTY, ILLINOIS

WHEREAS, Joliet Township, Will County, Illinois (the "Township"), is a duly organized and existing township and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of Illinois' Township Code, 60 ILCS 1/1-1, et seq., and all laws amendatory thereto; and

WHEREAS, the Illinois Open Meetings Act, 5 ILCS 120/1, et seq., permits attendance at meetings by means other than physical presence;

WHEREAS, in order to permit attendance by means other than physical presence, Section 7 of the Illinois Open Meetings Act requires a public body to adopt rules that conform to the requirements and restrictions provided therein;

WHEREAS, the Township desires to permit attendance of members of the public body by means other than physical presence in compliance with the Illinois Open Meetings Act;

NOW, THEREFORE, BE IT ORDAINED BY THE SUPERVISOR AND BOARD OF TRUSTEES OF JOLIET TOWNSHIP, WILL COUNTY ILLINOIS:

- Section 1. The above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made part hereof, as if fully set forth in their entirety.
- Section 2. The Remote Attendance Policy for Joliet Township, is attached as Exhibit A, and fully incorporated herein.
- Section 3. If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.
- Section 4. All ordinances, resolutions, motions, or order in conflict with this Ordinance are hereby repealed to the extent of such conflict.
- Section 5. This Ordinance shall be in full force and effect upon its passage, approve, and publication as provided by law.
