**Whereas**, it now appears that certain adjustments between appropriation line items in the Road and Bridge fund in such Ordinance are desirable and necessary: and,

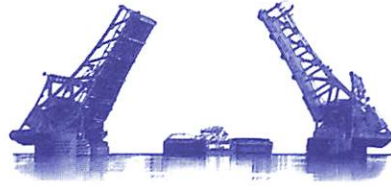

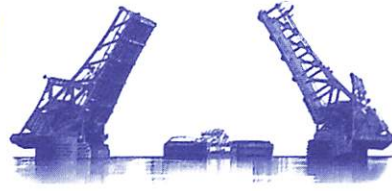
