A RESOLUTION AUTHORIZING THE EXECUTION OF A CONSULTANT AGREEMENT  
BETWEEN JOLIET TOWNSHIP AND JEFFERY M. WALLACE

**WHEREAS**, Joliet Township (“Township”) provides a variety of services and programs for senior citizens residing within the Township; and

**WHEREAS**, Jeffery M. Wallace has previously served as the Senior Liaison for Joliet Township and is familiar with the Township’s senior programs, outreach efforts, and community needs; and

**WHEREAS**, the Township desires to continue effective communication, outreach, and support for senior citizens through the services of a Senior Liaison;

**NOW THEREFORE, IT IS HEREBY RESOLVED** by the Board of Trustees of Joliet Township, Will County, Illinois, as follows:

**SECTION 1:** The foregoing recitals are incorporated in and made a part of this Resolution as though fully set forth herein.

**SECTION 2:** The Consultant Agreement between Joliet Township and Jeffery M. Wallace, attached hereto as EXHIBIT A, including all duties, responsibilities, compensation, term, termination provisions, and related terms, is hereby authorized and approved in all respects. The Township Supervisor is hereby authorized and directed to execute said agreement on behalf of the Township, substantially in the form attached.

**SECTION 3:** The Supervisor and the Township’s attorneys are hereby authorized and directed to take any and all actions and to prepare, execute, and deliver any and all documents necessary or appropriate to carry out the intent, provisions, and purposes of this Consultant Agreement.

**SECTION 4:** All prior motions or resolutions, or portions thereof, in conflict with this Resolution are hereby repealed or modified to the extent of such conflict. If any provision of this Resolution is held invalid, such decision shall not affect the validity of the remaining provisions.

**SECTION 5:** This Resolution shall be in full force and effect from and after its adoption as provided by law.
