**A RESOLUTION RATIFYING THE ELIMINATION OF CERTAIN FUNDED POSITIONS
DUE TO BUDGET CONSTRAINTS AND OPERATIONAL NECESSITY**

WHEREAS, Joliet Township, Will County, State of Illinois (the "Township") is a duly organized and existing township and a unit of local government organized under the laws of the State of Illinois and is operating under the provisions of the Illinois Township Code, 60 ILCS 1/1-1, et seq., and all laws amendatory thereto; and

WHEREAS, Section 80-10 of the Township Code (60 ILCS 1/80-10) grants the Township Board authority to examine and audit township accounts, adopt resolutions governing Township affairs, and approve expenditures necessary for Township operations; and

WHEREAS, Section 85-10 of the Township Code (60 ILCS 1/85-10) authorizes the Township Supervisor to act as the chief executive officer of the Township and to supervise and direct Township operations; and

WHEREAS, the Township has experienced budget constraints necessitating organizational restructuring to ensure the continued efficient delivery of Township services within available fiscal resources; and

WHEREAS, the Township Supervisor, in consultation with the Human Resources Director, determined that the elimination of certain funded positions was necessary due to budget constraints and operational necessity, and took proactive measures to implement such organizational restructuring prior to the next scheduled Township Board meeting; and

WHEREAS, the organizational restructuring actions included the elimination of the following funded positions, effective immediately:

- Administrative Clerk – Animal Control
- One (1) Animal Control Officer – Animal Control
- Tech Support / Data Researcher – Office of the Township Supervisor

WHEREAS, the actions taken were organizational in nature and not based on the performance of any individual employee; and

WHEREAS, the Township Supervisor and Human Resources Director authorized severance pay, final payroll processing, and benefits terminations in accordance with applicable law and Township policy for employees in the eliminated positions; and

WHEREAS, the Township Board finds it necessary and in the best interests of the Township to ratify and approve the prior executive actions taken related to organizational restructuring.

NOW, THEREFORE, BE IT RESOLVED by the Supervisor and Board of Trustees of Joliet Township, Will County, Illinois, as follows:

SECTION 1. RECITALS. The above recitals and findings are found to be true and correct and are incorporated herein and made a part hereof, as if fully set forth in their entirety.

SECTION 2. RATIFICATION OF POSITION ELIMINATIONS. The Township Board hereby ratifies and approves the elimination of the following funded positions, effective immediately, due to budget constraints and operational necessity:

- Administrative Clerk – Animal Control
- One (1) Animal Control Officer – Animal Control
- Tech Support / Data Researcher – Office of the Township Supervisor

SECTION 3. RATIFICATION OF ASSOCIATED ACTIONS. The Township Board hereby ratifies and approves all actions taken by the Township Supervisor and Human Resources Director associated with the elimination of the positions identified in Section 2, including but not limited to: severance pay, final payroll processing, and benefits terminations, all in accordance with applicable law and Township policy.

SECTION 4. BUDGET ADJUSTMENT. The Township Supervisor is hereby authorized to make such budget adjustments as may be necessary to reflect the elimination of the positions identified herein.

SECTION 5. SEVERABILITY. If any section, subsection, sentence, clause, phrase, or portion of this Resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 6. REPEALER. All resolutions, rules, and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded and repealed.

SECTION 7. EFFECTIVE DATE. This Resolution shall be in full force and effect immediately upon its passage and approval as provided by law.


