A RESOLUTION AUTHORIZING THE EXECUTION OF A CONSULTANT AGREEMENT  
BETWEEN JOLIET TOWNSHIP AND MOON & SUN CREATIVE LLC

**WHEREAS**, Joliet Township, County of Will, State of Illinois (the “Township”) is a duly organized and existing township and a unit of a local government organized under the laws of the State of Illinois and is operating under the provisions of the Illinois Township, 60 ILCS 1/1-1 et seq., and all laws amendatory thereto; and

**WHEREAS**, the Township desires to utilize Moon & Sun Creative LLC to provide public communications, marketing and outreach services to support the Township’s public engagement, internal communications and promotional initiatives; and

**WHEREAS**, the Township Board finds it in the best interest of the Township to retain the services of independent contractor, Isabel Gloria given the Township’s previous relationship with the individual in which they exhibited great experience with public communications, marketing, and outreach services for Joliet Township.

**NOW THEREFORE, IT IS HEREBY RESOLVED** by the Supervisor and Board of Trustees of Joliet Township, Will County, Illinois, as follows:

**SECTION 1:** The foregoing recitals are incorporated in and made a part of this Resolution as though fully set forth herein.

**SECTION 2:** The Consultant Agreement between Joliet Township and Moon & Sun Creative LLC, attached hereto as EXHIBIT A, including all duties, responsibilities, compensation, term, termination provisions, and related terms, is hereby authorized and approved in all respects. The Township Supervisor is hereby authorized and directed to execute said agreement on behalf of the Township, substantially in the form attached.

**SECTION 3:** The Supervisor and the Township’s attorneys are hereby authorized and directed to take any and all actions and to prepare, execute, and deliver any and all documents necessary or appropriate to carry out the intent, provisions, and purposes of this Consultant Agreement.

**SECTION 4:** All prior motions or resolutions, or portions thereof, in conflict with this Resolution are hereby repealed or modified to the extent of such conflict. If any provision of this Resolution is held invalid, such decision shall not affect the validity of the remaining provisions.

**SECTION 5:** This Resolution shall be in full force and effect from and after its adoption as provided by law.
