A RESOLUTION AUTHORIZING THE EXECUTION OF A CONSULTANT AGREEMENT
BETWEEN JOLIET TOWNSHIP AND OAK LEAF CEMETERY SERVICES

WHEREAS, Joliet Township, Will County, State of Illinois (the "Township") is a duly organized and existing township and a unit of local government organized under the laws of the State of Illinois and is operating under the provisions of the Illinois Township Code, 60 ILCS 1/1-1, et seq., and all laws amendatory thereto; and

WHEREAS, Joliet Township ("Township") owns, preserves, and maintains cemeteries; and

WHEREAS, Paul Cabay has previously served as the Cemetery Liaison for Joliet Township and is familiar with the Township's cemetery operations; and

WHEREAS, the Township desires to utilize Oak Leaf Cemetery Services to continue to provide administrative and operational support through the services of a Cemetery Liaison; and

WHEREAS, the Township desires to enter into an agreement with Oak Leaf Cemetery Services, with Paul Cabay serving as the designated individual, to provide such services (the "Consultant Agreement"); and

WHEREAS, the Township Supervisor and Board of Trustees have determined it is in the best interest of the Township to enter into this Consultant Agreement.

NOW THEREFORE, IT IS HEREBY RESOLVED by the Board of Trustees of Joliet Township, Will County, Illinois, as follows:

SECTION 1: The foregoing recitals are incorporated in and made a part of this Resolution as though fully set forth herein.

SECTION 2: The Consultant Agreement between Joliet Township and Oak Leaf Cemetery Services, attached hereto as EXHIBIT A, including all duties, responsibilities, compensation, term, termination provisions, and related terms, is hereby authorized and approved in all respects. The Township Supervisor is hereby authorized and directed to execute said agreement on behalf of the Township, substantially in the form attached.

SECTION 3: The Supervisor and the Township's attorneys are hereby authorized and directed to take any and all actions and to prepare, execute, and deliver any and all documents necessary or appropriate to carry out the intent, provisions, and purposes of this Consultant Agreement.

SECTION 4: All prior motions or resolutions, or portions thereof, in conflict with this Resolution are hereby repealed or modified to the extent of such conflict. If any provision of this Resolution is held invalid, such decision shall not affect the validity of the remaining provisions.


SECTION 5: This Resolution shall be in full force and effect from and after its adoption as provided by law.
