A RESOLUTION AUTHORIZING THE AMENDMENT OF A CONTRACTUAL
AGREEMENT BETWEEN JOLIET TOWNSHIP AND K&E CLEANING SERVICES

WHEREAS, Joliet Township, Will County, State of Illinois (the "Township") is a duly organized and existing township and a unit of local government organized under the laws of the State of Illinois and is operating under the provisions of the Illinois Township Code, 60 ILCS 1/1-1, et seq., and all laws amendatory thereto; and

WHEREAS, Joliet Township ("Township") is authorized to enter into contracts necessary for the operation and maintenance of Township facilities; and

WHEREAS, the Township has determined that professional cleaning and janitorial services are necessary to maintain a clean, safe, and sanitary environment for Township employees and the public; and

WHEREAS, K&E Cleaning Services has demonstrated the qualifications, experience, and ability to provide such services in accordance with the needs of the Township; and

WHEREAS, the Township desires to enter into an amended agreement with K&E Cleaning Services to provide such services (the "Contractual Agreement"); and

WHEREAS, the Township Supervisor and Board of Trustees have determined it is in the best interest of the Township to enter into this Contractual Agreement.

NOW THEREFORE, IT IS HEREBY RESOLVED by the Board of Trustees of Joliet Township, Will County, Illinois, as follows:

SECTION 1: The foregoing recitals are incorporated in and made a part of this Resolution as though fully set forth herein.

SECTION 2: The Contractual Agreement between Joliet Township and K&E Cleaning Services, attached hereto as EXHIBIT A, including all duties, responsibilities, compensation, term, termination provisions, and related terms, is hereby authorized and approved in all respects. The Township Supervisor is hereby authorized and directed to execute said agreement on behalf of the Township, substantially in the form attached.

SECTION 3: The Supervisor and the Township's attorneys are hereby authorized and directed to take any and all actions and to prepare, execute, and deliver any and all documents necessary or appropriate to carry out the intent, provisions, and purposes of this Contractual Agreement.

SECTION 4: All prior motions or resolutions, or portions thereof, in conflict with this Resolution are hereby repealed or modified to the extent of such conflict. If any provision of this Resolution is held invalid, such decision shall not affect the validity of the remaining provisions.

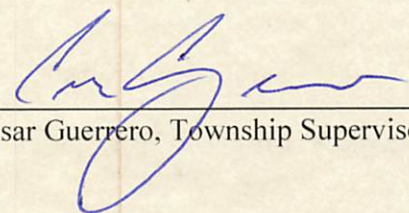
SECTION 5: This Resolution shall be in full force and effect from and after its adoption as provided by law.

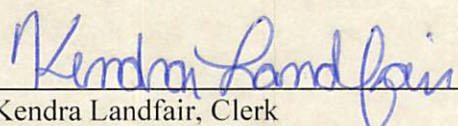
